A working spot includes all activities. Judge prospects (and licensed judges, at least once every 3 years) must attend a workshop with a working spot and perform all stages for the workshop to count toward their judge certification or continuing education. Working spot entrants must also submit course designs to Brydon by email brydon@barnhunt.com before Wednesday, April 1, 2026 (One complete single trial, Novice through Master with Crazy 8's between Open and Senior). A diagram of the ring will be provided upon receipt of the entry form and payment.

An audit spot includes the lecture only. However, auditors are encouraged to observe and participate in discussion during all stages of the workshop.

Please bring copies of the Barn Hunt rule books and anything else you think you may need. Note taking materials are particularly important. You may also want to bring a chair. We have folding chairs available, but you may be more comfortable in your own chair.

We will provide a light breakfast and lunch each day. Beverages will also be available. Fast-food options are available nearby.

****Those with working spots should not bring their own dogs unless necessary (e.g., nobody else at home to tend to them). Working spot attendees' dogs will not participate in the practice judging exercises.**

There is plenty of crating space available in the lecture space, but any dogs who are crated must remain quiet during the lecture. Potty breaks will be taken for the benefit of humans and dogs. A confirmation email will be sent to all entrants by April 25, 2026 and will include additional information.
